2801/21/TPO      T1: Oak - Crown thin by 20% to reduce sail effect;  
T2: Chestnut - removal of limbs x2 at approx 7m from ground level on South East side due to growing into neighbours tree; T3: Cherry - crown height reduction by 3m and lateral reduction by approx 2m on all sides - The Old Squash Court, Blachford Road, Ivybridge, PL21 0AD.

#### **OBJECTION**

**Members considered the variation would still result in a considerable increase in the size of the property not in-keeping with the area.**

**Members also felt the variation considerably increased the impact of the loss of light, and overshadowing, created by the relocation of the second story extension to the rear of the property, which would have a significant impact on the neighbouring properties.**

**For these reasons the Members of the Committee present unanimously objected to the application for variation of condition.**
