PL22/064 **HIGHWAY MATTERS:** The advert, statement of reasons, plans and draft amendment order from Devon County Council for waiting restrictions and parking places on Blachford Road, Ivybridge were received (copies previously circulated).

PL22/065 **PLANNING:** The following planning applications were considered:

4200/22/HHO Householder application for proposed rear conservatory – 22 Barn Close, Ivybridge, PL21 9UU.

OBJECTION – Due to the negative impact on neighbouring properties.

The proposed extension has a detrimental impact on No 20 Barn Close, the adjacent property to the rear, whereby the land slopes down from No 22 and is now looking directly into No 20. It is felt that this has an impact on privacy, and the residents of No 20 have raised objections on that basis.

The steps extending beyond the conservatory rear wall constitute a raised platform overlooking neighbouring properties, and permission for this should also be refused.

Due to the size of the conservatory it dominates the rear garden of this terraced dwelling, and Members also felt that the conservatory was very close to the boundary of the attached properties and will overshadow them significantly.

Taking all these factors into account, the proposal was considered overbearing and causing unacceptable harm, and Members therefore objected to the application.
