Hi Julie

As discussed our quotation is probably a much higher upfront cost to others but all the steel is brand new and cut to size on site to suit the openings, there is no monthly rental fees and no mandatory removal fee. We also use heavy duty anti tamper fixings which cannot be removed with normal tools.

Most other companies will be offering a low installation fee with a monthly rental fee. The problem with this method is the steel is re used over and over again resulting in the openings being secured with multiple off cuts of steel, this creates weak points and makes the steel much easier to lever or pull at resulting in continuous repeat break ins. I have attached some pictures of a site we re-secured earlier in the week which had been secured with the method. (not by us)

Another benefit with using a local company is if you do have problems down the line we are on hand to re secure quickly and cost effectively whereas the national companies will not be able to offer this service. We work with lots of other local councils and I'm sure they would be more than happy to recommend our services.
