PL21/083 **APOLOGIES:** Apologies were received from Cllrs R Jago, T Bowden, and T Munro

PL21/084 **INTERESTS TO BE DECLARED:** Cllr Budd declared a pecuniary interest in PL21/086 due to her husband's business involvement, and was absent from the meeting while this application was considered.

PL21/086 **HEDGE AND TREE MATTERS:** The following application for tree works was considered:

4253/21/TPO T1: Oak – Lateral crown reduction by up to 1.5m on the E side to provide 2m clearance to dwelling. Crown lift up to 4 m from ground level to clear electricity sub-station and allow more daylight under canopy – 8 Cameron Drive, Ivybridge, PL21 9TS.

Objection – In principle the council’s objections still stand due to the pressures placed on the town’s infrastructure. Members wish to seek assurance that a large proportion of S106 monies from the development will be allocated to Ivybridge to mitigate the demands placed on infrastructure, including a contribution towards health. With respect to affordable housing, Members requested that Devon Home Choice give priority to applicants with a local connection to the parishes of Ugborough and Ivybridge and then adjoining parishes.
