Brief outline of project

In accordance with the requirements of the client as outlined during conversation on 26th August 2022, the following needs to be undertaken:

Habitat Management Plan

Site Visit

A site visit will be undertaken to record and assess the habitats and species currently present within the site.

Report

Subsequent potential options for the provision of advice are presented below:

a) Verbal Advice

Subject to client availability, the site visit can be combined with a meeting to discuss the requirements of the site, with a brief summary of recommendations provided via email.

b) Habitat Management Report

A short report can be compiled based on the site visit. This would include a summary of the species, habitats and potential for wildlife within the survey area, together with ideas on enhancing current habitats for wildlife, the potential for creating additional habitats and managing the habitats for wildlife, including management techniques and timings.

c) Habitat Management Plan

A detailed Habitat Management Plan can be compiled which would utilise the information collected during the site visit to create detailed prescriptions and schedules regarding the current and proposed habitats and ecological features within the site. The status and current management of the habitats present within the site will be considered and recommendations will be made in order to enhance the habitats for a range of wildlife. Detailed recommendations could also be provided for the creation of additional habitats. An initial draft of the Habitat Creation & Management Plan will be provided to the client for comment.

The project will be undertaken by a suitably qualified, and where necessary licensed, inhouse ecologist.

It is assumed that the client will arrange access to all parts of the survey area as required by DWC and will supply maps of an appropriate scale for the project. Dates for completion will be agreed with the client on acceptance of the quote.

STANDARD TERMS AND CONDITIONS OF CONTRACT

Applicable to all Contracts undertaken by Devon Wildlife Consultants

- 1. The quotation is valid for a total of ninety days from the date on the quotation unless otherwise detailed in a covering letter or any other communication from Devon Wildlife Consultants (DWC).
- 2. All ecological data gathered during survey work will, 6 months after completion of the project, be passed on to the Devon Biodiversity Records Centre (DBRC), or equivalent Local Records Centre for survey work outside Devon, unless the Client instructs otherwise in writing. DBRC and other record centres use ecological data to produce information and analysis of their area's habitats and species, and any data passed on will therefore subsequently be in the public domain.
- 3. The Client is responsible for providing Ordnance Survey maps or digital data at a suitable scale, together with licence details where appropriate. Should DWC need to provide this data the cost will be met by the client.
- 4. The client is responsible for arranging access to the site(s) with the relevant landowners unless otherwise agreed. Where access requires DWC staff to obtain keys for sites the client undertakes to arrange this in advance. Time spent by DWC staff in obtaining keys or otherwise engaged in securing access will be chargeable to the client at an hourly rate commensurate with the fees set out in the quotation.
- 5. If evidence is found of the presence of a species or habitat that may be a material consideration for a development, project or other activity other than the species for which DWC is contracted to survey and report, DWC has a professional obligation to report on the presence of these species and reserves the right to refer to these species in the same report as the species for which DWC was contracted to survey.
- 6. If evidence is found of harm to wildlife and wildlife habitat, whether accidental, deliberate or reckless, DWC reserves the right to consult with the statutory authorities. If Planning Conditions or other agreements are broken, whether accidental, deliberate or reckless, DWC reserves the right to consult with the Planning Authorities. If license agreements are broken, whether accidental, deliberate or reckless, DWC reserves the right to consult with the licensing authority. If any of the above is considered likely to occur, DWC reserves the right to consult in advance with the appropriate authority.
- 7. The fee payable to DWC by the Client for the Contract covers only the work which DWC undertakes to carry out in relation to the Contract in the letter from DWC to the Client setting out the basis on which the Contract is to be carried out. In the event of additional work being required by the Client this will be charged for as an extra. If additional expense is incurred by DWC in order to fulfil the Contract due to errors in plans, specifications or information provided by the Client at the time of tender request, then the Client will reimburse such additional expense to DWC.
- 8. Goods or materials which are supplied during the contract will remain the property of DWC until receipt of payment.
- 9. The Client agrees to pay invoices upon receipt of invoice unless otherwise agreed in writing prior to the issue of invoices.
- 10. For ongoing works, invoices will be issued on a monthly basis unless otherwise agreed in writing prior to commencing the contract.
- DWC reserves the right to charge interest on overdue sums (over 30 days from date of invoice) in accordance with the Late Payment of Commercial Debts (Interest) Act 1998 and Late Payment of Commercial Debts Regulations 2002.
- 12. Where recourse to legal process is required to recover monies due to DWC, solicitor's fees, court costs and other incurred expenses will also be claimed from the client.
- 13.
