- PA23/032 PARKS & OPEN SPACES EVENT GUIDANCE & CONDITIONS OF HIRE DOCUMENT AND BOOKINGS FORM REVISED: To consider the revised Event Guidance and Conditions of Hire Document, and bookings form, for adoption (copy attached).
- PA23/033 POP UP COFFEE & CAKE FACILITY FILHAM PARK: To consider a request from Skate South Devon CIC to site a small pop up facility selling food (cakes) and drinks (coffee) at Filham, in order to raise money towards the proposed wheeled sports park (copy of request attached).
