The chairperson asked the committee if there was anything in the re-advertisement that would cause them to change their views from the previous application which they had supported based upon material planning considerations.

Cllr Austen responded by proposing the application was discussed at Full Council rather than at the Planning Committee due its scale. Cllr Austen's proposal was not seconded. He then highlighted concerns from Environmental Health, Devon Highways and the proximity of the site to Ivybridge Methodist Church due to it being a Grade II listed building.

The rest of the committee did not consider that anything additional had come forward to affect their previous recommendation to support the application. The re-advertised plans demonstrated an improvement with the increase of parking spaces to ten vehicles, and there were mitigations proposed to address the concerns raised by Environmental Health, Highways and the appearance of the site.

A vote was recorded at the request of Cllr Austen.

OBJECT - Pound Farm Lane is a public right of way and a busy pedestrian route. The chairperson had visited the site and observed 40 pedestrians, mostly schoolchildren, using the route around school finishing time over the course of ten minutes. This lane is also popular with the older section of the community visiting the health centre. The committee considered it to be an unsuitable location for a commercial building.

They also highlighted the absence of any drainage or soakaway. In addition, the plans were queried due to them referring to a proposal for two garages.

The committee therefore wished to object to the proposal for the following reasons:

**Commercial use is out of keeping with the setting;
The building has no suitable drainage installed;
The existing plan shows a proposal for two garages and the Committee wished to seek clarification regarding this.**
