Ivybridge Neighbourhood Plan

Thank you for providing NEW Devon Clinical Commissioning Group, Western Locality, the opportunity to view and comment on your exciting plans.

NEW Devon CCG's Western Locality and Plymouth City Council have recently published the second draft of four commissioning strategies seeking feedback from providers and other stakeholders across the health and wellbeing system. The strategies apply to health services commissioned by NEW Devon CCG across the Western Locality and care services commissioned by Plymouth City Council across Plymouth. We work in partnership with other organisations including Devon County Council to determine our commissioning strategies and plans and are interested in feedback.

These strategies embrace the vision that is also set out in the draft Ivybridge Neighbourhood Plan of building a town that promotes a healthy, creative and sustainable lifestyle. The aims of an Integrated Health and Wellbeing System are:-

1. To improve health and wellbeing outcomes of the local population
2. To reduce inequalities in health and wellbeing of the local population
3. To improve people's experience of care
4. To improve the sustainability of our health and wellbeing system.

The Ivybridge Neighbourhood Plan's objectives (set out below) echo the vision of the Western Locality of healthy people living healthy lives in healthy communities. This all stems from promoting prevention and wellbeing.

1. Supporting strong, vibrant and healthy communities, by providing the supply of housing required to meet the needs of present and future generations; and by creating a high quality built environment, with accessible local services that reflect the community's needs and support its health, social and cultural well-being;
2. Growing and enhancing the town's good reputation for sport.
3. Encouraging sport and exercise particularly among teens and elderly.
4. Improving sports facilities.
5. Improving cycle routes and implementing dual use of school pitches and facilities.

We have sent your original email requesting feedback and comment on the Neighbourhood Plan to NHS England, requesting that they correspond separately. NHS England's Area Team are the team that contracts with GP practices for core primary medical services and GP premises and therefore they will be interested to read of your plans to create a health and

leisure hub incorporating new leisure and medical centres.
